SELECTMEN PRESENTS

TOWN ADMINISTRATOR REPORT

Auditor Update

TA Beaulieu informed the Board that the audit process went well. One of the questions from the auditors was regarding the process the board follows when approving wage increases. Wage increases are typically approved as part of the budget during town meeting. The auditors would like the selectmen to sign approval of wage increases as entered into the accufund system. The Board agreed.

Concerned Citizen

TA Beaulieu informed the board that a concerned citizen form was received regarding construction activity at 2259 Route 175. The citizen explained that an existing garage building is being converted to a home at the property known as PID #10/5-7, owner David Atwood. The Board discussed the concern. The lot is ½ an acre, and at this time there is only a garage on the property. TA Beaulieu recommended asking the property owner to apply for a ZCA. R Sabourn suggested sending the property owner a letter letting them know that a ZCA application is needed as well as a state approved septic design. The property owners should also be informed that a concern has been received regarding construction activity. Chairman Sabourn suggested sending a copy of the letter to the Atwood's to the concerned citizen as a response.

DRA-2015 Cyclical Monitoring

TA Beaulieu informed the Board that the final results of the monitoring activity were received for the cyclical inspections of property values.

NH Electric Coop

TA Beaulieu presented a letter in response to a request received from NHEC to change the Town's form used to process the licensing of utility poles and underground conduits in Thornton. The letter included the Board's response that the Town will continue to require the use of the form as implemented by the Town of Thornton.

Health Trust

TA Beaulieu has been researching other health insurance options. The plan currently held by the town will no longer be offered. She has researched options with the Health Trust. The new plan is more affordable but has a higher deductible. She is working on an option to offset the deductible for employees. The Health Trust suggested that the Town cover most of the deductible but not all. They suggested that the employees have a vested interest in making sure not to overuse their insurance by participating in preventative measures offered by the Health Trust. She also discussed having an FSA account for employees as a benefit as well. The Board agreed that TA Beaulieu should investigate this option to try to come up with the best solution.

Town Meeting Minutes

Town Meeting Minutes were received by the Board. Chairman Sabourn submitted some suggestions for edits.

Plodzik and Sanderson, Auditors

TA Beaulieu informed the Board that they were asked to fill out a fraud questionnaire by the town audit firm Plodzik and Sanderson. The Board reviewed the form during the meeting as TA Beaulieu transcribed their response. The Chairman signed the questionnaire form on behalf of the Board.

6:36 p.m. Murray Movitz- Judges Road

Present: Russell Gilman, Cliff McCuin, John Kubik, George Humphrey, Murray Movitz, Craig Antonides, and James Sheils. Signature sheet is attached, two additional members were present though signatures were not clear.

M. Movitz read a letter of concern regarding areas of Judges Road and he informed the Board of his desired response from the Selectmen to address these issues.

Chairman Sabourn informed the residents that the Road Agent and Selectman John Paul-Hilliard have been working on a plan to improve the road. Chairman Sabourn asked that Selectman Paul-Hilliard and Road Agent Kubik address the plan that is in progress for Judges Road.

Selectman Paul-Hilliard explained that the board has worked on a system with the RA to consider the *priority level* or severity index of the more than 50 miles of roadway owned by the Town of Thornton, along with frequency of residence, traffic count, etc. He recognized that a lot of correspondence has been generated between the residents on Judges Road and the Selectmen's office. He also recognized that the town's biggest and most expensive asset to preserve is the town's roads. Selectman Paul-Hilliard recalled that the installation of regrind millings was discussed during the previous site meeting. This is still a possibility in the future but requires an extensive amount of work to be done prior to installation. RA Kubik is working within his ability to fix some areas of the road as time and finances permit, including some

drainage and trimming the tree canopy. Selectman Paul-Hilliard explained that another option is the use of grader shim that could be used this year and would improve the ride factor of Judges Road. He explained what grader shim is and how it is used according to his experience with the NH- Department of Transportation. He would recommend more pipe inspections and additional canopy work to let more sun on the road to help dry up areas. This needs to be done once the frost has lifted. Selectman Paul-Hilliard assured the residents that they have not been ignored and that the town has working on a plan that the town can afford to address the road concerns.

RA Kubik presented a draft five year paving schedule and he explained how the roads have been evaluated. The plan is expected to be altered each year depending on needs that arise as time goes on. He has broken down the 50 miles of town roads into manageable sections. In reviewing the plan created, in 2019 Judges Road could be rehabilitated. RA Kubik informed the residents that the Selectboard has done a good job tending to the road needs of the town by increasing the paving budget to address road concerns in town.

A concerned citizen explained that the town has not maintained the road and the road is in a bad situation. M. Movitz stated that he appreciated that board is being forthcoming.

Another citizen stated that he is impressed with Selectmen Paul-Hilliard's explanations and suggestions as well as the long term schedule to repave the road as mentioned by RA Kubik. M. Movitz hopes that the RA will visit the road within the next few weeks to see the bad spots and address the bad spots by the fall.

Another citizen commented that the proposals concern him because the underneath of the road is not in good condition. He would like to see a good road foundation for a long term solution rather than spending money on repairs that may not last. Selectman Paul-Hilliard explained that the grader shim can be installed yearly if needed and that will also help rebuild the base.

RA Kubik plans to make repairs to the road until the paving budget allows the highway department to repave the road. Chairman Sabourn recommended trimming the tree canopy, working on culverts and eliminating as much water as possible to preserve what is there, and further considering grader shim installation to improve the ride factor as well.

M. Movitz asked that the Road Agent schedule a site meeting at Judges Road with the residents to discuss problem areas. Chairman Sabourn informed the residents that the RA will visit the road and can determine the needs of the road without meeting with the residents. The Board and the Road Agent has met with the residents and has done a site visit and are very aware of the condition and needs of the road. The Road Agent will move forward with the repairs and improvements as discussed this evening.

7:15 p.m. Philip McCuin - Solar Lights on 6 Mile Bridge

Cliff McCuin informed the Board that residents have expressed an interest in having the lights fixed on the 6 mile bridge as they have been out of service for a long time. The residents in the area would like the lights turned back on. Gateway homeowners association owns the lights and discontinued the power. C. McCuin is recommending that solar lights be installed rather than lights requiring electricity. The town would have to give permission since it is a town bridge. The Board agreed that they would approve Gateway homeowners association to install solar lights as long as the proposal is sent to the town insurance company and the Board has the opportunity to review their recommendations. The association would need to explain their intent with a written request to install the lights for the board to review so the Board could assess for potential liability. C. McCuin agreed to forward this information to the association.

7:30 p.m. Highway Department- various topics

The paving schedule was discussed during the appointment earlier with residents from Judges Road. The board agreed with the proposed plan.
