Nonresident Registration (RSA 261:46): Notwithstanding RSA 261:45, a nonresident who garages a vehicle *exclusively* in this state may register such vehicle in this state as a nonresident.

A NEW OUT-OF-STATE NON-RESIDENT VERIFICATION FOR CAMPER FORM SHALL BE COMPLETED AND PRESENTED EACH YEAR TO RENEW THE CAMPER REGISTRATION.
